*Bodily injury and property damage liability (2)

Liability protection for you against claims for bodily injury (including death) and damage to others' property not in your care or custody. Not included are claims for damage to the non-owned aircraft. Liability protection for you against claims for bodily injury (including death) and property damage after you have given instruction applies only if the instruction given and the bodily injury and property damage arise from an accident which occurs while the policy is in force.

**Aircraft damage liability (3)

Liability protection for you for damage to the non-owned aircraft. This includes loss of its use and the owner's deductible.
